A. Review, discussion and approval of the Emergitech aka Zuercher Technologies maintenance agreement with CDAA for 12/1/2017 thru 11/30/2018. PUBLIC COMMENT WILL BE TAKEN PRIOR TO ANY EXECUTIVE BOARD ACTION: ACTION ITEM

Donna explained this is the yearly maintenance agreement in the amount of \$25, 590.07 for the phones for the year 12/01/2017 thru 11/30/2018. Jolene abstained because of the working relationship between Eagle Communications and Emergitech.

B. Review, discussion and approval of fiscal year 2016/2017 annual audit. Audit was completed by Eide Bailly. Teri Gage from Eide Bailly will present audit. PUBLIC COMMENT WILL BE TAKEN PRIOR TO ANY EXECUTIVE BOARD ACTION: ACTION ITEM

Teri Gage with Eide Bailly presented the 2016/2017 audit for CDAA. Teri advised that CDAA had a clean opinion. She advised there was not a lot of differences. Cash went from \$398,000 to \$542,000. The biggest increase was Unit Costs. The Unit count was reduced by 5. In the general fund, the revenue was over \$48,000. This was due to a June 30, 2016 error found in billing. The radio cost was billed at 7872 and should have been billed at 8375. Salaries increased from 13 to 15 people and services and supplies were down. The ending fund balance is \$419,000, which is at 29% (you want at least 8.3%). There was no capital outlay. Jolene made a motion to accept the CDAA 2016/2017 audit as presented. Bill Hance seconded.
